The Vice Chancellor of University shall be appellat authority of Anti Ragging Committee

The function of the Anti-ragging Committee shall be as under:

- 1) To root out ragging in all its forms from the University by prohibiting it by law; preventing its occurrence by following the provisions of these regulations and punishing those who indulge in the same despite of 'prohibition and prevention' as provided for in these regulations & the appropriate law in force.
- 2) It shall consider the recommendations of the Anti-ragging Squad and take appropriate decisions, including spelling out suitable punishments to those found guilty.
- 3) The Anti-ragging Squad will have visit, oversight and patrolling functions. It shall be kept mobile, alert and active at all times and shall be empowered to inspect places of potential

ragging and make surprise raids on hostels and other hot spots. The squad shall investigate incidents of ragging and make recommendations to the Anti-ragging Committee and shall work under the overall guidance of the said committee.

- 4) The Anti-ragging Committee shall also review the efforts made by such departments to publicize anti-ragging measures, cross-verify the receipt of undertaking from students and their parents/guardians every year and shall be the prime mover for initiating action by the University authorities to suitably amend the statutes or ordinances or bye-laws to facilitate the implementation of anti-ragging measures at the level of the University.
