Sir,

I am directed to refer this Ministry's letter dated 18<sup>th</sup> October, 2016 wherein Ram Krishna College of Homoeopathy & Medical Sciences RKDF University, Airport by Pass Road, Gandhi Nagar Campus, Bhopal MP was granted permission to start a new homoeopathic college and hospital from the Academic Session 2016-17 with intake capacity of 100 students under the provision of Section 12 A of the HCC Act, 1973 with the condition to fulfill all the requirement as per HCC Act and relevant regulations made thereunder and to develop the requisite infrastructure for IInd, IIIrd and IVth BHMS well in time for obtaining permission for taking admission for subsequent Academic Session.

2. The CCH has conducted inspection of your college on 22.05.2017 to verify the compliance report and to assess the available facilities of teaching and practical training in the college as per the required norms and conditions prescribed under section 12A of the HCC Act, 1973 and the regulations made thereunder and submitted the inspection report.

3. The Central Government while examining the inspection report of CCH in terms of the provisions of HCC (MSR), 2013 has observed that the college is not fulfilling the following basic eligibility conditions:-

- i. NIL House Physician (Resident) available against required 02.
- ii. In Department of Anatomy Mummified bodies not Available.


4. In view of the above pointed out deficiencies, you are hereby given an opportunity of hearing as a natural justice of being heard in terms of provisions of the first proviso to subsection 4 of section 12 A of the HCC Act, 1973 at **10.30 AM** on ~~17.12.17~~... before the designated Hearing Committee in the Ministry of AYUSH. You are given an opportunity to present your case and to show cause as to why the admission should not be stopped in BHMS course for the academic year 2017-18 as per the provisions of HCC (MSR), 2013.

5. It is further directed that you may bring along and submit all possible oral and written submissions with valid documents/records/proof to substantiate your claims against all the deficiencies/shortcomings as indicated above during hearing for evidence/verifications by the Central Government.

6. It may please be also noted that in case you do not attend the hearing at the stipulated time and date, it will be presumed that you have nothing to say in the matter and necessary action will be taken based on available records as per the provisions of the HCC Act, 1973 and the relevant regulations made there under.
