The Proceeding of 25<sup>th</sup> Board of Management meeting which was held on 25<sup>th</sup> June 2020 was approved.

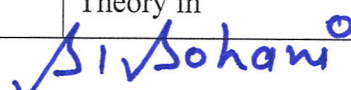
### Agenda No. 2:- Action Taken Report on Major decisions Taken in the 25<sup>th</sup> Meeting of Board of Management
