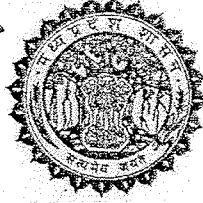
**Clarification regarding name of HEI**

THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN)  
DWITIYA SANSHODHAN VIDHEYAK, 2011.

A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007.

Be it enacted by the Madhya Pradesh Legislature in the Sixty-second year of the Republic of India as follows:—

Short title

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Dwitiya Sanshodhan Adhiniyam, 2011.

Amendment of Schedule.

2. In the Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), after serial number 6 and entries relating thereto, the following serial number and entries relating thereto shall be inserted, namely:—

S. No. (1)	Name of private University (2)	Name of sponsoring body (3)	Mode of forming sponsoring body (4)	Main Campus (5)	Jurisdiction (6)
"7.	Ram Krishna Dharmarth Foundation University	Ayushamati Education and Social Society, Bhopal.	Registered Society under the M. P. Society Registrakaran Adhiniyam, 1973 (No. 44 of 1973)	Ram Krishna Dharmarth Foundation University, Near R. G. P. V. Campus, Airport Bypass Road, Bhopal (M. P.)	Whole of Madhya Pradesh."

STATEMENT OF OBJECTS AND REASONS

Section 5 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), provides for evaluating of the proposal of establishment of Private University in the State by the Regulatory Commission constituted under the Act. Under the said provision, the Regulatory Commission has recommended to establish the Private University, in the name of Ram Krishna Dharmarth Foundation University at Bhopal. Under Section 6 of the said Act, the State Government has issued a letter of intent to the sponsoring body of the said University, for the said purpose. Section 9 of the said Act provides that after being satisfied with the report submitted by the Regulatory Commission, a Private University shall be established by incorporating the name and description thereof in the Schedule to the said Act.

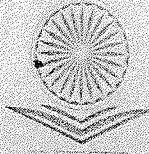

Sub - Establishment RKDF University Bhopal (Madhya Pradesh) as a Private University.

Sir,

With reference to State Government Notification No. अ-4437-245-इयजीस-अ-(प्र.) dated 19.07.2011 on the above subject, I am directed to say that RKDF University, Bhopal (Madhya Pradesh) has been established by an Act (No. 17 of 2007) - amended Madhya Pradesh Bill No. 23 of 2011 (**The Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Dwitiya Sanshodhan Vidheyak, 2011**) of State Legislature of Madhya Pradesh as a State Private University and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its main campus with the approval of statutory bodies / councils, wherever required.

As per the judgement of the Hon'ble Supreme Court in the case of Prof. Yashpal Vs State of Chhattisgarh there is no provision to have Regional Centres / off Campus beyond the territorial jurisdiction of the State.

Keeping in view of the above, you are requested to adhere on the following:-


1. No off campus centre(s) is opened by the University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yash Pal Vs State of Chhattisgarh.
2. In case the University has already started any off campus centre outside the State, it must be closed immediately. It may also be ensured that any off campus centre within the State shall be opened only as per the provision laid down in the UGC (Establishment of and maintenance at standards in Private University) Regulation 2003 and with the prior approval of UGC.
3. The University shall not have any affiliated Colleges.
4. The University has to follow UGC (Minimum standards and procedure for award of M.Phil / Ph D degree) Regulations, 2009.

The University is required to follow the UGC (Establishment of and Maintenance of Standards in Private University) Regulation, 2003 (copy enclosed) & other Regulations issued from time to time and posted on UGC website [www.ugc.ac.in](http://www.ugc.ac.in)

You are also requested to send the information in the prescribed format (copy enclosed) for inspection purpose as per UGC Regulations referred to above within one month from the date of receipt of this letter.
